STALLION CONTRACT FOR TRANSPORTED SEMEN

I hereby confirm my reservation to the stallion _____ for the year _____

for my mare _____ Reg. Number _____ -Breed _____

For the stud fee of \$ _____, Booking Fee included.

1. Mare Owner agrees to pay Stallion Owner the stud fee with payment being due before shipment of semen.
2. Upon full payment, Woodland View Farm agrees to ship cooled semen to the Mare Owner. Call prior to semen request to verify collection dates and times. (Normally we collect Monday, Wednesday and Friday. Orders need to be called in the evening before or before 6:00 a.m. on collection day. We collect our studs early so Dr. Kline can go onto his other calls by 7:00 a.m.)
3. Mare Owner agrees to pay \$200.00 per collection for any additional shipment after the first shipment. (FIRST SHIPMENT IS INCLUDED IN STUD FEE.)
4. Mare Owner agrees to pay all shipping and postage fees on all shipments (INCLUDING THE FIRST SHIPMENT) such as FEDEX, AIRLINE FEES plus special pick-up fees if ordered by Mare Owner.
5. Semen will be shipped in an approved shipping container, which Mare Owner agrees to pay a deposit of \$250.00 for Equitainer. EQUITAINERS MUST BE RETURNED WITHIN 4 DAYS OR A CHARGE OF \$25.00/per day WILL BE CHARGED UNTIL ITS RETURN. (This deposit is not necessary if Mare Owner uses MasterCard or Visa.
6. When being returned, EQUITAINERS MUST BE INSURED FOR \$250.00.
7. Mare Owner will be called and given a tracking number for package, the day of shipment.
8. Should said mare _____ not conceive in the current breeding season, she may be returned in the next season with the same privileges. After the end of the second breeding year, contract will be fulfilled.
9. Should said mare _____ be examined to be unfit for breeding at any time during breeding, Mare Owner may substitute another mare.
10. Should the mare not produce a live foal that stands and sucks, the Mare Owner shall be entitled to a return breeding. This guarantee shall be only if the Stallion Owner is notified by registered mail within 48 hours of the foal's death. A statement of details by licensed veterinarian must follow within 10 days or the guarantee becomes null and void. This clause is, also, binding in case of abortion.
11. Mare Owner shall assume all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whether by death, injury, infection or otherwise, and by cause whatsoever, and therefore agrees to hold the Stallion Owner and/or manager harmless for any and all damages associated therewith.
12. This is limited live foal contract with contract ending _____, and is NOT TRANSFERRABLE IF MARE IS SOLD TO A NEW OWNER.
